WHAT DO I NEED TO APPLY FOR MY CHINA TOURIST VISA?

TOURIST VISA:

Passport with at least 2 blank pages, and valid for a minimum of 6 months.

Photocopy of the passport's data page (the main page with all the personal information).

If the photo is not on this page, a separate photocopy of the photo page must be included as well.

Computer Typed Visa Application Form.

Completed Declaration Form.

1 colour passport size photo (48mm x 33mm), taken against a light background in the last three months, which must be different from the photo in the current passport. This must comply with the Chinese Visa Centre's Photo Specifications

Photocopy of the most recent previous Chinese visa, if any. If applying for a multiple entry visa, the copy provided should be of the last multiple entry visa. Hong Kong and Macau entry stamps are not included in this requirement.

EITHER payment receipt for flights and confirmation of hotel bookings covering the entire stay in China,

OR

invitation letter from an organisation or individual in China which:

*includes information about the applicant, including their full name, gender and date of birth;

*includes details about the planned visit, including its purpose, arrival and departure dates, place(s) to be visited and accommodation arrangements;

*includes information about the inviter, including name, contact telephone number, address, official stamp of the organisation (if applicable) and Chinese ID number of the individual inviter (if applicable);

*states the relationship between applicant and inviter;

*specifies the source of financial support while in China; *signed, dated and addressed to the Embassy of the People's Republic of China in the UK

*accompanied by a photocopy of either both sides of the inviter's Chinese ID (if a Chinese citizen), or the inviter's passport and residence permit (if not a Chinese citizen).

FOOTNOTES:

1. Entry is permitted on this visa up to the last day of the passport's validity.
2. If arriving in China from any country other than directly from the UK, a full flight itinerary both from the UK to China and from China back to the UK must be included.
3. Itinerary, invitation and any additional documents should be emailed as attachment (if original not required)
4. This must be an official Chinese stamp - these are typically red, circular, and have Chinese writing around the outside with a star in the centre.
5. If the signatory is Chinese, the letter must use the Chinese version of their name and they must sign in Chinese characters. A foreign name and a signature in western characters can only be used if that is the name in the signatory's passport, in which case a copy of the passport must also be included.

***NB: If you are not applying for the visa in the country of your citizenship, you must provide the original and photocopy of your valid certificates or visa of stay, residence, employment or student status, or other valid certificates of legal staying provided by the relevant authorities of the country where you are currently staying.**

Where should I send my documents?

How long does the visa take to be organised?

The standard processing time is 10 working days from when we receive your passport and application.

How much time can I spend in China?

The standard allowed time per stay is 30 days so should say "The standard allowed stay per entry is for up to 30 days however 90days can be granted if specifically requested on the application form.
